Crude oil dropped amid profit taking and concerns that rising numbers of COVID-19 cases in China. Natural gas gained on forecasts for higher demand this week than previously expected, colder-than-normal weather coming in late January.

Base Metal

Copper eased as concerns surrounding lower global growth halted the rally triggered by China's economic reopening. Inventories at the LME and SHFE warehouses fell to under 186.4 thousand tonnes, enough to support global consumption for just over two days.
