Bullion

Gold prices rose to 57000 level as the dollar's retreat amid expectations for a less-aggressive interest rate hike strategy from the U.S. central bank made bullion a more attractive bet. Prices also rose backed by expectations that the U.S. Federal Reserve might increase rates by only 25 basis points at each of its first two meetings this year, after slowing its pace to 50 bps in December 2022.

Energy

Crudeoil dropped amid concerns about a global economic slowdown and expected build in U.S. oil inventories. Natural gas settled flat on expectations of lower demand after forecasts pointed to a milder weather in the next 2 weeks.

Base Metal

Copper prices rose on improving prospects for demand in top consumer China, low inventories and a weaker dollar. Also, on the agenda is a spate of U.S. data on growth, manufacturing and price pressures, which may yield clues to the Federal Reserve's monetary policy intentions.
