Asian Stocks Edge Higher as Investors Await Powell

<u>SMIFS</u> LIMITED

US and European equity futures and Asian stocks made small gains as investors awaited commentary from Federal Reserve Chair Jerome Powell later Tuesday. A gauge of the region's shares rose about 0.6%, trimming losses from the biggest two-day drop in four months, as investors weigh the chances of the Fed keeping a firm grip on monetary policy. Some of the strongest gains Tuesday were in tech stocks listed in Hong Kong — providing a sharp contrast to the decline in US equities Monday, when the S&P 500 and the tech-heavy Nasdaq 100 both finished lower as bond yields rose. Baidu Inc. surged as much as 13% after affirming it will launch a ChatGPT-like bot in March. Treasuries clawed back some of the two-day rout that was sparked by traders ramping up bets on future Fed tightening. The recent move have taken the shine off the best start to a year for cross-asset returns since 1987. Australian bonds fell following the moves in the US market and before an interest rate decision from the central bank, which is forecast to hike by 25 basis points. Investors are weighing whether Powell may emphasize that optimism for rate cuts later in 2023 is probably misplaced. Atlanta Fed President Raphael Bostic said Monday the strong jobs data on Friday raises the possibility that the central bank will need to increase interest rates to a higher peak than policymakers had previously expected.

Oil Extends Gain as Saudi Arabia Bets on Demand Rebound in Asia

Oil rose for a second session after Saudi Arabia unexpectedly raised its crude prices to Asia, signaling confidence in the demand outlook. West Texas Intermediate futures edged toward \$75 a barrel after closing 1% higher on Monday. Saudi Aramco increased most of its prices for crude that will be shipped to its main market of Asia in March, amid growing optimism over a robust demand rebound in China following the end of Covid Zero. Supply outages also added to bullish tailwinds for oil. Turkey halted flows to the Ceyhan export terminal after a major earthquake, while output at Norway's giant Johan Sverdrup field was lower due to a power disruption.

California Governor Seeks Federal Probe on Soaring Gas Bills

California Governor Gavin Newsom called for federal energy regulators to investigate a recent hike in natural gas prices that has resulted in sky-high utility bills. Newsom, a Democrat, asked the Federal Energy Regulatory Commission in a letter to look into whether market manipulation, anticompetitive behavior or other activities have driven up the cost of gas in the US West, according to a statement Monday. The call for a probe comes after the wholesale price of natural gas in Southern California soared to more than nine times that of US natural gas benchmark futures in December, prompting California utilities to warn of shockingly high bills. Several factors have contributed to the soaring prices including colder-than-normal weather, reduced pipeline capacity due to maintenance and low gas storage levels in the US West.

China's Copper Producers Raise Output Even as Demand Falls Short

China's copper producers were at their most active in seven months in January, according to an analysis of smelting activity, promising more supply for a market already burdened by large stockpiles and weak demand. At the end of January, only a couple of Chinese smelters were observed as inactive, according to SAVANT, a service provided by broker Marex Group Plc and geospatial analysis company Earth-i, which monitors up to 90% of operations globally. That raised output by 2% from December's level to 744,000 tons, contributing to a record month for global production, Marex said in a statement. China's smelting industry, the world's largest, typically expands production every year as more capacity is added. It has an incentive to lift runs even further in 2023 after processing fees were set at a six-year high to account for rising output at copper mines around the world. January is usually a strong month as smelters look to meet an increase in consumption after the Lunar New Year holiday, Marex said. But demand has so far disappointed this year, confounding hopes that China's reopening after abandoning its Covid Zero restrictions would lift prices. Spot copper currently trades at a discount in China, stockpiles have continued to build, and the premium paid for refined metal at the port of Yangshan, a measure of import demand, has dropped to its lowest since April. For nickel, the analysis showed a drop off in Chinese activity over the month, although the most recent data suggests a rebound at the start of February.
