Gold steadied as Federal Reserve Chair Jerome Powell's latest remarks sounded less hawkish than markets anticipated. He said that more rate hikes will likely be needed and that the terminal rate could peak higher if the jobs market remains strong, but maintained that disinflation has begun.

Crude oil rose as investor concern eased about U.S. interest rate hikes and an industry report pointed to a drop in U.S. crude inventories. Natural gas dropped on a slow rise in output as warmer weather thaws frozen oil and gas wells.

Base Metal

Copper dropped after reports Glencore copper mine in Peru has reopened with increased security. Pressure also seen on demand concerns and a firmer dollar more than offset supply disruptions.
