losses. Turmeric prices dropped as turmeric harvesting has started in
the key growing regions. Jeera prices dropped as harvesting have
started in the Cumin growing regions and it is in process which may
get complete by the end of this month.

O Mentha oil dropped on profit boooking after prices rose on improving export demand especially from China.

O Turmeric prices dropped as turmeric harvesting has started in the key growing regions

O Jeera prices dropped as harvesting have started in the Cumin growing regions and it is in process which may get complete by the end of this month.

O Dhaniya prices seen pressure as harvesting has started and hence arrivals started with 15%-30% moisture

O Castor prices dropped as Castor seed output in India is projected to increase by 15 per cent to 19.46 lakh tonnes for the year 2022-23.
